CMS is proposing to change the number of points assigned to the OASIS items that drive reimbursement in the Patient-Driven Groupings Model (PDGM). See chart below for the proposed changes to the number of points that CMS could attach to these OASIS items in 2022. The numbers in parenthesis in the right column show the points that could be added or deleted to the corresponding OASIS items. (*See related story*, *p.* 5.)
